



## Terms of Use for Participation in and Posting on the Manassas VA H.O.G. Chapter Facebook Group Page

The Manassas VA H.O.G. Chapter ("Chapter") Facebook Group page is managed by the Chapter administrators: the Director, Webmaster and Membership Officer ("Administrators").

The purpose of the Chapter Facebook Group is to provide an engaging forum to share information related to Chapter activities and motorcycling in general. All users of the Chapter Facebook Group ("Users") are encouraged to participate. These Terms of Use are intended to help Users understand and differentiate between suitable and inappropriate use of the Chapter Facebook Group and to define best practices for participation in this Group.

By accessing, browsing, or using this service, each User agrees to be bound by these terms. The Administrators may at any time revise these Terms of Use by updating this posting; User's continued use of the service following the posting of a notice of a change will confirm User's acceptance of any such changes.

### Rules and Restrictions on Submissions

1. Users should exercise common sense and courtesy in submitting comments or materials for posting on the Chapter Facebook Group ("Submissions"). Inappropriate Submissions would include, by way of example, comments or materials that:
  - a. make false or defamatory statements about others;
  - b. are obscene, vulgar, abusive, hateful or threatening;
  - c. harass or discriminate on the basis of race, religion, nationality, ethnicity, gender, sexual preference or other factors;

- d. are invasive of the privacy rights of others (e.g., by including addresses, phone numbers or other personal information about third persons without their consent.)
2. Users may not use the Chapter Facebook Group to promote or provide instructional information about illegal activities or for any purpose that may be illegal.
3. User submissions may not contain comments or materials supporting or opposing any candidates for political office nor otherwise engage in political activity.
4. Users may not use or attempt to use the Chapter Facebook Group for commercial purposes. Submissions may not include advertisements for goods or services, solicitations, "spam", chain letters, surveys, pyramid schemes or the like.
5. Users may not use the Chapter Facebook Group to promote or advertise any motorcycle-related group or organization other than the Manassas VA H.O.G. Chapter, nor any dealer or business selling motorcycle parts, accessories, or apparel other than Bull Run Harley-Davidson.
6. Users may not use the Chapter Facebook Group to promote or advertise any event other than those of the Manassas VA H.O.G. Chapter or Bull Run Harley-Davidson.

## Procedures for Requesting the Removal of Inappropriate Submissions

Any User who believes that material posted on the Chapter Facebook Group is inappropriate may request that the material be removed from the Chapter Facebook Group by notifying the Administrators.

## Administrators' Right to Monitor and Administer the Facebook Group

Administrators reserve the right to monitor and administer the Chapter Facebook Group and, in their sole discretion, to remove any content posted to the Chapter Facebook Group. Administrators also reserve the right to disallow the use of any particular screen name or e-mail address, or to terminate any User's posting privileges at any time, including individual and group postings.

## Compliance with Facebook Terms and Conditions

Users must comply with the terms identified in the Facebook User Agreement.
